Terms of Service

I. Introduction

Welcome to Symbiotic STEM. Please carefully read this document to learn the rules and restrictions governing your use of our website (the “Services”).

These Terms of Service (the “Terms”) are a binding contract between you and Symbiotic STEM (“Symbiotic STEM,” “we,” and “us”). You must agree to and accept all the Terms, or you don’t have the right to use the Services. By accessing or using the Services in any manner, including but not limited to visiting or browsing Symbiotic STEM's website or contributing content or other materials to Symbiotic STEM's platform, you agree to be bound by these Terms.

II. Modification

Symbiotic STEM reserves the right, at its sole discretion, to modify these Terms at any time and without prior notice. If we modify these Terms, we will either post a notification of the modification on our website or otherwise provide you with notice of the change. The date of the last modification will also be posted at the beginning of these Terms. It is your responsibility to check from time to time for updates. By continuing to access or use the Services, you accept and agree to be bound by any modified Terms.

III. Privacy Policy

IV. Eligibility

- To impersonate or attempt to impersonate Symbiotic STEM, a Symbiotic STEM mentor, a Symbiotic STEM mentee, another user, or any other person or entity; or
- To engage in any other conduct that restricts or inhibits anyone's use or enjoyment of the Services or may harm the owners and operators of Symbiotic STEM.

Additionally, you agree not to:
